TERMS & CONDITIONS

- 6. **Entry Instructions:** Participants must enter their Promotional Code and contact details online at www.lerustique.com. The required code can be found in the sticker on the outside of the promotional Le Rustique de Printemps products and on the promotional neck collar on bottles of Calvet Wine (Calvet Cahors Malbec 75cl, Calvet Bordeaux Fleur Baron Red 75cl, Calvet Limited Release Bordeaux Sauvignon Blanc 75cl, Calvet Limited Release Bordeaux Merlot 75cl, Calvet Prestige Bordeaux Merlot Cabernet Sauvignon 75cl, Calvet Prestige Bordeaux Sauvignon Blanc Cuvée Fumé 75cl, Prestige de Calvet Côtes du Rhône Villages 75cl).
